



LED 5 Year Limited Warranty

This Warranty only covers defective LED products manufactured by Eclipse Lighting Inc. when properly installed and under normal conditions of use and does not cover any component products manufactured by "Others". "Other" products, such as LED Drivers, Dimming Modules, Battery Backups, Motion/Occupancy/ Light Harvesting sensors and controls, carry their own warranties and should be considered before returning any products. Eclipse Lighting Inc. will not accept items without prior written return authorization #. Any unauthorized return, repair, replacement or modification of the Product(s) shall void this warranty.

IN NO EVENT SHALL SELLER BE LIABLE FOR INCIDENTAL, COMPENSATORY, CONSEQUENTIAL, INDIRECT, SPECIAL OR OTHER DAMAGES. SELLER'S AGGREGATE LIABILITY WITH RESPECT TO A DEFECTIVE PRODUCT SHALL IN ANY EVENT BE LIMITED TO THE MONIES PAID TO SELLER FOR THAT DEFECTIVE PRODUCT.

The buyer agrees to make all claims regarding defects or deficiencies in the Product(s) according to the terms of Eclipse Lighting Inc. warranty. Warranty claims must be made in writing. Valid warranty claims must be made within the warranty period specified herein above, and submitted within thirty (30) days of discovery of the damage or defect. NO FIELD LABOR, REPAIR, DISMANTLING, OR INSTALLATION CHARGES ARE INCLUDED WITH THIS WARRANTY.

For any breach of this limited warranty, the exclusive remedy of Customer and the sole liability of Eclipse Lighting Inc., shall be, at the option of Eclipse Lighting Inc., to replace or repair the affected products. The availability of replacement products is subject to product discontinuance policies of Eclipse Lighting Inc. All LED modules are warranted against defect for a period of **(5)** five years from date of purchase to the original buyer with proof of purchase. This warranty does not cover costs of removing and re-installing the light fixture or the parts.

THE WARRANTIES SET FORTH HEREIN ARE EXCLUSIVE. ECLIPSE LIGHTING INC., DISCLAIMS ALL OTHER WARRANTIES, WHETHER EXPRESS, IMPLIED OR STATUTORY, INCLUDING, WITHOUT LIMI-TATION, ANY WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR NON -INFRINGEMENT, AND ANY WARRANTY THAT MAY ARISE FROM COURSE OF DEALING, COURSE OF PERFORMANCE, OR USAGE OF TRADE.

This warranty does not cover acts of nature such as lightning damage, or corrosion and discoloration of components caused by exposure to gases such as chlorine, sulphur or other harsh chemicals in the air, surface contamination due to the mishandling of the light engines, nor does it cover damages caused through abuse, improper installation, surges in electric current, acts of third parties, or any error, neglect or default of Customer. Retrofit Kits when field installed have 1-Year Warranty.

Failure of an LED module is defined as having more than 3 LED's in any one circuit of LED's fail. This warranty is null and void if the product is not installed within the manufacturer's strict guidelines/Instruction sheet, or if any of the following occur: under/over voltage, under/over current or any damage arising out of any acts of god, external forces, surges, fire, misuse or abuse or any other factor not under control of Eclipse Lighting Inc.

This warranty is effective for purchases of product on or after the effective date set forth below. Seller reserves the right to modify this warranty from time to time. Any modification of this warranty shall be effective for all orders placed with Seller on or after the effective date of such revised warranty.

*Components and LED Drivers are pro-rated as follows: year 1-5 = 100%, year 6 = 50%, year 7 = 40%, year 8 = 30%, year 9 = 20%, year 10 = 10% off purchase cost of replacement from our list price sheet in effect at the time of failure.
